This is a public advertisement under section 4 of the Human Rights Commission Act, (Cap. 3:08 of the Laws of Malawi), directed to the organizations described in section 131 (1) (c) of the Constitution of the Republic of Malawi, (the Constitution).

The organizations listed below are invited to nominate up to 2 persons (one male and one female) who are independent, non-partisan and of high professional integrity and standing, from within or outside the nominating organization, for appointment as a member or members of the Human Rights Commission (the Commission). The nominating organizations should give full names, contact details and curriculum vitae of the person they nominate. The person(s) so nominated should have sound knowledge of human rights.

Nominations in response to this advertisement will result in the filling of vacancies at the expiry of tenure of office of the existing members of the Commission (seventh cohort) as prescribed by section 5 (1) and (2) of the Human Rights Commission Act, (Cap. 3:08 of the Laws of Malawi).
